KEYNOTE ADDRESS

Conor O'Driscoll Master Distiller Heaven Hill Distillery

Conor O'Driscoll has made quite the name for himself in the distillery world. He has taken an uncommon path starting with school in his native Ireland to a career with Pfizer, to becoming a world-renowned distiller manager and master distiller at Kentucky's largest single-site distillery: Heaven Hill. His innovative approach to learning all aspects of his job have led him down the paths of working in microbiology, fermentation science, and chemical engineering.

Like so many of our Pls, O'Driscoll's background is in the sciences, and like so many of us, his career took him on an unexpected journey. He was born in Dublin, Ireland and attended the University College Dublin to complete his degree in Chemical Engineering. He moved to the United States in 1989 and has worked at industry powerhouses such as Pfizer and Aker Kvaerner before transitioning to the world of whiskey. He visited Kentucky in 2002 and decided upon a different, course altering path: distilleries. He was hired by Brown-Forman in 2004 as their Operation Manager. In 2009, he made the transition to Woodford Reserve Distillery to oversee their operations and expanded his skillset to warehousing and processing responsibilities. From there, O'Driscoll moved on to lead operations at Angel's Envy Distillery in 2017.

O'Driscoll's holistic approach to not just learning the different aspects of the industry, but embracing all the different elements, escalated him to the forefront of his field. In 2019, historic Heaven Hill Distillery announced O'Driscoll as their seventh Master Distiller during their 87-year tenure. He's only the second Master Distiller without the last name of Beam, which makes the feat even more impressive! Attendees will enjoy hearing from this local figure who has applied his scientific background and technical expertise in such a unique and interesting way.

- Overview: Content is an overview of a topic and does not go too deep, but it provides the surface level or big picture for take-a-away objectives.
- Intermediate: Content leans toward the seasoned research administrator or manager.

Advanced: Content level is complex and focused and leans toward the director and senior level.

REGION BUSINESS MEETINGS: Region III holds a Business Meeting each year at the Spring Meeting. As a bonus, it's during lunch and everyone has to eat, so come eat and learn about what our fabulous region is doing. Everyone is welcome and encouraged to attend!

SESSION DEFINITIONS:

Concurrent Session are 60- to 75-minute formal presentations. These sessions are usually lecture-style and have accompanying slides, but they are encouraged to be more interactive. Case studies and other structured creative activities are welcome. There is usually some question and answer time built in at the end. Proposals for concurrent sessions must include two or three specific learning objectives. Proposals for concurrent sessions should have at least two presenters. Discussion Group are small group, facilitated conversations. Instead of formal presentation, the specific topics are discussed and information is shared by the group's attendees.

Discussion Groups are small group, facilitated conversations. Discussions are 60- to 75-minutes long and should usually have no more than two facilitators. Discussion group leaders promote active participation by suggesting a direction, posing questions, keeping the discussion on topic, helping participants make connections, etc. Specific learning objectives are not required. As discussion groups are usually in rooms with no A/V capabilities, no slides are required.

Workshops are deep-dive presentations, traditionally supported with slides and handouts. They are taught by subject matter experts in a classroomstyle setting. Presenters may propose either a half-day or a full-day workshop, depending upon the subject matter to be covered. Workshops require three or more learning objectives. If you have not already signed up for a workshop, don't miss out! You may register on-site at the registration desk. Please note that there is an additional cost associated with workshop offerings.

TRACK DEFINITIONS: Tracks are designed to ensure that attendees are able to choose topic-specific sessions to further learning and meet educational objectives.

Pre-Award: Sessions related to finding funding, putting proposal teams together, writing proposals, developing budgets, institutional review and approval processes, proposal submission, and post-submission follow-up activities such as resubmission.

Post Award: Sessions related to award setup, financial management, re-budgeting, expenditure review, subrecipient monitoring, financial reporting, audit, cost sharing, closeout, etc.

PUI: predominantly undergraduate institutions, Sessions of interest to research administrators who work at institutions that are generally more focused on teaching than research, serve a mostly undergraduate student body, and/or are relatively new to applying for external funding and managing sponsored research projects.

Compliance: Sessions related to all areas of research compliance, including risk assessment, animal care and use, human subjects, conflict of interest, export controls, data management, responsible conduct of research, environmental health and safety, etc.

Departmental: Sessions of interest to research administrators who report to an academic unit, research center, lab, or even a single PI.

Federal: Sessions related to funding opportunities, rules, and regulations for federal grants and contracts.

Organizational Development: This track focuses on techniques and tools to improve business processes and logistics including personnel recruitment, using eRA and Cloud solutions to improve processes, managing organizational communications and change, supporting faculty through new organizational models, and more.


